

Declaration and Agreement:

- 1) I hereby apply for AIG's Mobile Insurance Service ("Service Link"). This application is made by me in my capacity as technical representative working for an insurance broker ("my company"). The Service Link enables me, in this capacity, to place certain insurance business to AIG HK which AIG HK may then bind and effect policy issuance in an automated manner. I also understand that nothing in this declaration is intended to make me, or my company, into an agent of AIG HK and that at all times I use the Service Link, I and my company remain agents for the insured.
- 2) I agree to abide by any instruction which may be given by AIG HK from time to time in relation to the use of this Service Link, including but not limited to any payment terms relevant to any insurance policy.
- 3) I understand that AIG HK shall deliver a monthly statement setting out the policies issued by AIG HK placed by me using the Service Link and which are registered under my user ID. This statement shall include, the gross premium and the remuneration to which my company is entitled to in accordance with the Commission Table which is issued by AIG HK to my company/me from time to time. My company, whether acting through me or otherwise, will be responsible for the payment of the net premium set out in such monthly statement, but we are entitled to net off the commission from the gross premium collected from the insured. Payment (and the effect of non-payment) of such premium is dictated by the policy terms and conditions.
- 4) I understand that I am fully responsible for the security of my user information relating to my use of this Service Link and shall not provide this information to anyone else.
- 5) I acknowledge the need to provide accurate customer information and data when utilizing the Service Link to place any insurance policy for customers with AIG HK.
- 6) I agree that the personal data requested in this form will only be used for AIG HK to process my application for the Service Link and that the data may be transferred to third parties involved in this process and I may request access to or correct such data AIG HK holds by writing to the Privacy Compliance Officer of AIG HK at cs.hk@aig.com.
- 7) I acknowledge that:
 - a. no authority is given to me:
 - i. to accept risks on behalf of AIG HK;
 - ii. to issue cover notes or policies or bind AIG HK in any other manner;
 - iii. to receive notice of termination or assignment of any policy; or
 - iv. to waive breach of any condition of any policy,and I shall not represent to a prospective policyholder(s) that I am authorized to do any of these actions.
 - b. I shall not represent that a risk has been accepted or cover effected or policy issued by or on behalf of AIG HK unless AIG HK expressly notifies its acceptance by issuing the policy through the Service Link or otherwise;
- 8) I undertake to comply with all applicable laws and regulations in Hong Kong, including, without limitation, the Prevention of Bribery Ordinance (Cap. 201 of the Laws of Hong Kong, the "PBO") and the Personal Data (Privacy) Ordinance (Cap. 486 of the Laws of Hong Kong).
- 9) I also acknowledge my/my company's duties with regards to disclosure of remuneration as set out in the rules of membership or other regulations of the regulatory body to whose jurisdiction I am/my company is subject and I warrant that for any policy I place through the Service Link such regulations have been complied with.
- 10) If at any point I cease to be licensed as a Technical Representative, my right to access the Service Link shall automatically cease. I shall notify AIG HK immediately this occurs and cease using the Service Link.
- 11) If I change employer to work for another broker, my continued right to access the Service Link is contingent on me notifying AIG HK of this change and obtaining AIG HK's consent to being able to continue to access the Service Link. Such change shall require a new ID access so I accept the need to fill in a separate application in this respect.
- 12) I take note of the AIG HK's Privacy Statement and, to the extent necessary, I shall explain its terms to my customers so they are aware of how AIG HK uses the data I input into the Service Link, to whom such data may be transferred and who the customer may contact if they have any queries about their data.


